**Form 4: Rules of Conduct for Players' Agents**  
**The Basketball Super League for Men (2002) Ltd.**

Within the framework of my request to receive a players' agent license from the Basketball Super League Administration for Men (2002) Ltd. (hereinafter: "League Administration"), I the undersigned, give my full consent to abide by the rules of ethics of the players' agents below:

1. The agent has an obligation of trust to the player he represents.
2. The agent will furnish the team with which he is interested in connecting the player, all material information pertaining to the player he wants to add to the team, including (but not only), information including health-medical history (including past injuries and wounds), history of criminal offences and/or indictments, and also history of prohibited substance use. In this regard it is prohibited to conceal material information from the team.
3. The agent will represent skillfully and professionally and will uphold the dignity of the profession, the dignity of the represented player and the dignity of the basketball institutions, including the Basketball Super League, the Israel Basketball Association, the referee and arbitration institutions of the Israel Basketball Association, basketball referees and basketball teams.
4. The agent is prohibited from entering into a conflict of interests towards the player he represents.
5. The agent has an obligation of information confidentiality towards the player he represents and towards the team with which he is interested in connecting the player, expect for material information and information which by virtue of its nature should be transferred between the player and the team. Regarding third parties external to the representation and the connections, the agent will maintain complete confidentiality of information.
6. The agent will not execute legal activities considered to fall within the realm of the legal profession.
7. The agent is prohibited from causing a breach of contract between the represented player and the agent who represents him. Regarding this rule, the rules and laws concerning "inducement of breach of contract" tort applies.
